## **Job Summary:**

Plans, implements, supervises and evaluates activities provided in the Teen Center, such as Education, Computer Lab, the Arts, Physical Education and Health and Wellness. Helps at the front desk with membership check-in, concessions, game check-out/in, answering phones and cleaning duties.

Promote the components of health, wellness and fitness to achieve the goals of the organization.

# **Job Responsibilities:**

- Promote and stimulate program participation, including the area of health, wellness and fitness.
- Participate in new member Club orientation process.
- Provide guidance and role modeling to members.
- Effectively implement and administer programs, services and activities as assigned.
- Monitor and evaluate programs, services and activities to ensure safety of members, quality in programs and appearance and cleanliness of the unit at all times.
- Prepare periodic activity reports.
- May be required to drive club van.
- May participate in special programs and/or events.
- Mandated child abuse reporter.

## **Physical and Mental Requirements:**

- Must be able to interact physically with children during program activities.
- Ability to sit or stand for long periods of time.
- Ability to lift a minimum of 50 lbs.
- Must be able to think clearly and concisely.
- Must be able to function in a loud environment with high energy interacting with multiple aged members.
- Must be able to work in a variety of environments, including outdoor activities possible trip assignment.
